ChristTown Ministries Inc. Moving Services Tariff

Effective Date: June 30, 2025

Section 1: General Rules and Regulations

1. Scope of Service

ChristTown Ministries provides moving services for household goods, office equipment, and other items as permitted by the DOT. Our services are available for local and interstate moves.

2. Tariff Coverage

This tariff applies to all shipments accepted for transportation by ChristTown Ministries. It includes charges for packing, loading, transportation, unloading, and any additional services requested by the customer.

3. Eligibility for Services

ChristTown Ministries reserves the right to refuse services in situations where:

- Items exceed the legal weight limits
- Items are prohibited by law
- The customer fails to meet payment requirements

4. Additional Charges

The following charges may apply, depending on the specific needs of the move:

- **Fuel Surcharge:** A surcharge will apply based on fluctuating fuel prices.
- **Hourly Charges:** Applicable for moves that require more time than initially estimated.
- **Stair or Elevator Charges:** Additional charges for moves requiring stair or elevator services.
- **Long Haul Charges:** Charges for moves beyond 50 miles from the point of origin.

Section 2: Rates and Charges

1. Base Rates

- **Local Moves** (under 50 miles): \$214.00 per hour, with a minimum of 2 hours.
- **Long Distance Moves** (over 50 miles): \$214.00 per hour or as per the negotiated contract.
- **Packing Services:** \$214.00 per hour; additional charges apply for specialty items like fragile or oversized goods.

2. **Weight-Based Charges**

Charges for long-distance moves may vary based on the weight of the shipment. A weight scale certificate will be provided upon request, and charges are determined by the actual weight of the goods.

3. **Add-On Services**

- **Packing Material Charges:** Market price.
 - **Storage Charges:** \$20.00 per day, if applicable.
 - **Express Delivery:** as negotiated; for expedited services.

Section 3: Payment and Billing

1. **Billing Information**

Payment is due upon completion of services. A deposit of as negotiated % of the total estimated moving cost is required at the time of booking. The remaining balance must be paid on the day of delivery.

2. **Methods of Payment**

We accept [Cash, credit cards [3.5% charge on total contract price], and checks.

3. **Late Payment Charges**

Any balance not paid within 15 days of the agreed delivery date will incur a late fee of 20% per month.

Section 4: Claims and Liability

1. **Liability for Goods**

ChristTown Ministries assumes liability for loss or damage to goods in transit in accordance with the DOT regulations. The maximum liability for loss or damage is \$25,000 unless the customer opts for additional insurance coverage.

2. **Filing Claims**

Claims for damages or loss must be filed within 10 days of delivery. A written claim must be submitted to ChristTown Ministres with supporting documentation.

Section 5: General Terms and Conditions

1. **Service Hours**

Services are available Monday through Friday from 9am to 5pm. Weekend services may be available upon request, with an additional charge.

2. **Delays and Cancellations**

Customers must notify ChristTown Ministries at least 48 hours in advance to cancel or reschedule a move. A cancellation fee of \$500/day set aside for move applies for less than 48 hours' notice.

3. **Subcontractors**

ChristTown Ministries reserves the right to use subcontractors for part of the moving services, but will retain responsibility for the entire shipment.

4. **Customer Responsibilities**

The customer is responsible for ensuring that items are packed appropriately before the move and that there are no hazardous materials in the shipment. A list of prohibited items will be provided upon request.

Section 6: DOT Compliance

1. **DOT Motor Carrier Number:** 4431751

ChristTown Ministries is licensed by the DOT and complies with all applicable federal regulations concerning the transportation of household goods.

2. **Insurance**

We maintain the required levels of insurance to meet DOT standards, including cargo insurance and liability insurance for our vehicles and employees.
